A note about MAIA Simulated Data Products

The MAIA Simulated Data Products are the result of pre-launch software tests and research with other data sources that can be used as proxies for MAIA data. These products are available to MAIA Early Adopters, with the goal of facilitating the use of MAIA data post-launch. Early Adopters can determine whether the MAIA products contain the information needed for their work, and begin development of any code, tools, or procedures needed to integrate MAIA data into their workflow. Early Adopters can also provide feedback on the accessibility and usability of the MAIA data (obtaining the products, formats, content, available tools and user resources), which the MAIA team hopes will result in better products and greater use of MAIA data, as well as better outcomes for the Early Adopters.

The MAIA Simulated Data Products are made with training data, including existing satellite data, chemical transport data output, and surface monitor data. The performance and accuracy of the Simulated Data is not intended to be representative of the production MAIA data. If you decide to use MAIA Simulated Data in research or publication, please ensure you have a complete understanding of the dataset(s) and their intended use.
